The selection process is based on the following requirements. Please use this as a Checklist before submitting your application. Any applications that do not meet ALL the following requirements will not be considered for selection.

- The STUDENT applicant must be a member of the credit union in good standing.
- The application must be complete and signed by both the student and parent/guardian.
- The applicant has provided:
 - Official High School Transcript
 - Official ACT or SAT score report.
 - Minimum of One Letter of Recommendation
 - Completed Essay

Letter of Recommendation / Character Reference

Attach a minimum of one (but no more than three) letters of recommendation. Note that letters from family members of the applicant will not be accepted. Consider asking teachers, coaches, employers, club advisors, or leaders of volunteer opportunities. Think about those who know your strengths well and remember to ask well in advance of the application deadline.

Application Authorization

This application must be signed, completed, and submitted to Coosa Pines Federal Credit Union for consideration. The application will not be considered if an applicant fails to complete the entire application and provide all requested information. The applicant must be an account holder with Coosa Pines Federal Credit Union. To receive the scholarship, the recipient must attend an accredited four-year or junior college, technical school, or vocational school of the recipient's choice. The scholarship will be granted only to a graduating high school senior and will be announced and awarded in the spring prior to the recipient's graduation. However, the scholarship is contingent upon the recipient graduating from high school. The scholarship will be paid to the educational institution of the recipients' choice upon proof of enrollment. If awarded a scholarship Coosa Pines FCU has the right to use the recipient's name and picture for printed and video materials, reports, advertising, internet, and press releases, without compensation. All information from the application will be released to the Coosa Pines Federal Credit Union Scholarship Selection Committee. The committee does not discriminate based on race, color, sex, religion, or national origin during the application process. By submitting the application and all applicable attachments, and with signatures below, the applicant and parent/ guardian certify that the information submitted is true and correct and agree to the scholarship conditions outlined in the application document.
